Consequent upon the approval conveyed by the higher authorities and in light of satisfactory report of character and antecedent received from the Criminal Investigation Department, J&K, sanction is hereby accorded to the appointment of Mr. Muzafar Ahmad Khanday S/o Late Ghulam Mohi-ud-din Khanday, Ex Music Composer, Cultural Unit, Srinagar R/o Bun Mohalla, Anchidora, Azadpora, Anantnag, as Multi Tasking Staff (Class-IV) in the Pay level of SL-1 (14800-47100), in the Information Department, UT Cadre, under SR0-43 of 1994.

The appointee shall report to the Directorate of Information & Public Relations, J&K, Srinagar within a period of twenty one (21) days from the date of issuance of this order, failing which he shall forego his right to appointment and the same, shall be deemed to have been cancelled abinitio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates/documents (in original) to be verified subsequently:-

1. Academic Qualification Certificate issued by the recognized Institute/University valid for employment.

2. Matriculation/Date of Birth Certificate from recognized education Board.

3. Domicile certificate issued by the competent authority.

4. Health Certificate from the concerned Chief Medical Officer of the District.

5. Valid relevant category certificate issued by the competent authority, if any applicable.

6. All other relevant documents as are required under SRO-43/1994.

The appointment of the appointee shall further be subject to the following conditions:

- a. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification / Date of birth / Reserved Category Certificates from the concerned issuing authorities, are found fake / forged, the claim of the appointee as MTS (Class-IV) shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- b. That he shall give an undertaking in the shape of an Affidavit duly attested by the Judicial Magistrate First Class, to the effect that the applicant is unemployed as on date and none of the family members other than the applicant has taken benefit of compassionate appointment under SRO-43. In case it turns out that the applicant is already appointed or the benefit of compassionate appointment under SRO-43 of 1994 has been already extended to the family of the deceased, then the instant appointment shall be deemed to have been withdrawn ab-initio without any further notice.
- c. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile district, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government services. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a selfemployment unit/enterprise and recovery to be made and also personally monitor its recovery.

d. The salary of the appointee shall not be drawn and disbursed to him unless the satisfactory reports in respect of genuineness of academic qualification /date of birth/relevant category certificate is received from the concerned issuing authority.

e. The appointee shall be on probation for a period of two years.

f. The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.

- g. The inter-se-seniority of the appointee in the J&K Information Department (Sub-ordinate) Services shall be determined as per the J&K Civil Service (Classification, Control and Appeal) Rules, 1956.
- h. The appointee shall retain his lien in his cadre.

The appointment of the above appointee shall be subject to the outcome of writ petition(s), if any, pending before any Competent Court of law.
